



How to Submit a Continuing Review (aka, annual renewal) in KP

1. Go to <https://colostate.kuali.co/protocols/> and select “CSU System” to log in with your CSU NetID and password.



2. Select the protocol you need to renew.
3. Click ‘Renew & Amend’ located to the right side of the protocol.



4. In the **Continuing Review Form** section, located at the top portion of the protocol, please select

one of the two options:

- a. If your project has not yet been initiated or is inactive, please select the appropriate option.
